| The legal basis for processing your personal data | <p>The legal basis for the collection and processing of your personal data is:-</p> <ul style="list-style-type: none"> <li>• administration: that it is necessary to fulfil the contract that you are going to enter into or have entered into with us;</li> <li>• disclosure to those approved by you: that you have given your consent by selecting them on the system to receive your information;</li> <li>• in all other cases: that it is necessary for our legitimate interests which are to build a programme to encourage participation in cricket and does not prejudice or harm rights and freedoms of participants or parents / guardians of children that join the programme.</li> </ul> |

| Your right to withdraw consent                    | <p>You have the right to withdraw your consent at any time.
